**MINUTES OF THE PROCUREMENT COMMITTEE MEETING**

**Subject: EVALUATION OF BIDS FOR PROCUREMENT OF LAPTOPS UNDER THE SPECIAL GRANT FOR THE "CHIEF MINISTER'S DIGITAL INCLUSION PROGRAM FOR MINORITY STUDENTS"**

A meeting of the Procurement Committee was held on 8th June, 2026 at 12:00 PM in the office of Deputy Secretary, Auqaf, Hajj, Religious & Minority Affairs Department, Peshawar to evaluate the bids received through E-PADS for procurement of 500 laptops under the "Chief Minister's Digital Inclusion Program for Minority Students". The meeting was attended by the following members:

**Proceedings**

The meeting commenced with the recitation from the Holy Quran. The Chairman welcomed the participants and briefed the forum regarding the procurement process.

The Committee was informed that the procurement was initiated through open competitive bidding single stage one Envelope under the KPPRA Rules. Tender Notice was published in the leading newspapers namely Daily Mashriq and Daily Nawai Waqt on 14th May, 2026 and was also uploaded on E-PADS, KPPRA and the official website of the Auqaf, Hajj, Religious & Minority Affairs Department. A Pre-Bid Meeting was held on 21st May, 2026 wherein various queries raised by prospective bidders were discussed and necessary clarifications were incorporated in the revised Standard Bidding Documents (SBDs).

The bids were opened through E-PADS on 3rd June, 2026 at 2:30 PM in the office of Deputy Secretary Auqaf. A total of five (05) firms participated in the bidding process, namely:

- ii. M/s Broad Peak Enterprises

- iv. M/s OREL Vision IT Consulting (Pvt.) Ltd.
- v. M/s Aursoft Private Limited

The Committee thoroughly reviewed the technical proposals, mandatory eligibility documents, affidavits, financial proposals and laptop samples submitted by the bidders. The Technical Members from ST&IT Department and KPIT Board assisted the Committee in evaluating compliance with the prescribed technical specifications.

The Committee evaluated all bids strictly in accordance with the Mandatory Eligibility Criteria, Technical Specifications and other requirements stipulated in the Standard Bidding Documents (SBDs). Only bidders meeting all mandatory requirements were considered responsive and eligible for further evaluation.

**i. M/s Hans Enterprises**

The Committee observed that the bidder failed to fulfil a number of mandatory requirements including Active Sales Tax Registration, requisite experience, submission of Income Tax Returns, Audit Reports, ISO Certification, completion of the required number of contracts, delivery schedule and warranty undertaking. Accordingly, the bidder failed to qualify the mandatory evaluation criteria and was declared non-responsive and disqualified.

**ii. M/s Broad Peak Enterprises**

The Committee observed that the Sales Tax Registration of the bidder had been suspended by the Federal Board of Revenue (FBR) and the bidder was not appearing as an Active Taxpayer on the Active Taxpayer List (Sales Tax). Furthermore, the bidder quoted HP 250 G10 Laptop in its proposal; however, the sample produced before the Committee was a Dell Laptop, resulting in inconsistency between the submitted proposal and the sample. The bidder also failed to submit the Manufacturer Authorization Letter (MAL) in the name of the Procuring Entity, which was a mandatory requirement under the bidding documents. Accordingly, the bidder was declared non-responsive and disqualified.

**iii. M/s Megaplus Pakistan**

The Committee observed that M/s Megaplus Pakistan submitted a Non-Blacklisting Affidavit and informed the Committee that the blacklisting order issued by the Federal Investigation Agency (FIA) had been challenged before the Hon'ble Islamabad High Court, which had suspended the blacklisting order. The Committee decided that clarification/opinion may be sought from the relevant procurement regulatory authority regarding the legal status of the bidder in light of the court proceedings.

However, the Committee further observed that the bidder failed to submit sample of laptop as per specifications prescribed in the Standard Bidding Documents (SBDs). Since submission of a conforming sample was a mandatory requirement, the bidder failed to qualify the mandatory evaluation criteria and was therefore declared non-responsive and disqualified.

**iv. M/s OREL Vision IT Consulting (Pvt.) Ltd.**

The Committee observed that the bidder failed to provide multiple mandatory requirements including bid security, registration documents, experience requirements, turnover requirements, audit reports, Manufacturer Authorization Letter, affidavits, warranty commitment and sample submission. Accordingly, the bidder failed to qualify the mandatory evaluation criteria and was declared non-responsive and disqualified.

**v. M/s Aursoft Private Limited**

The Committee thoroughly reviewed the proposal submitted by M/s Aursoft Private Limited and observed that the firm successfully fulfilled all mandatory eligibility and qualification requirements prescribed in the Standard Bidding Documents.

The firm submitted valid bid security, FBR and Sales Tax registrations, ISO 9001:2015 Certification, audited financial statements, income tax returns, evidence of relevant experience, Manufacturer Authorization Letter, affidavits, warranty commitments and supporting documentary evidence.

### Samples Evaluation

The Technical Evaluation Committee physically examined and verified the laptop samples submitted by the participating bidders against the technical specifications prescribed in the bidding documents.

The sample submitted by Aursoft was found fully compliant with the required technical specifications and was in accordance with the details provided in its bid submission.

The sample submitted by Hans Enterprises was found non-compliant with the prescribed specifications. The bidder had offered a Lenovo ThinkPad E16 Gen 2 laptop with an Intel Core i7 (13th Generation) processor and 16 GB DDR5 RAM in its bid submission. However, upon examination, the physical sample submitted was a Lenovo IdeaPad Slim 3 15IRH8 equipped with an Intel Core i5-13420H (13th Generation) processor and 8 GB RAM. Therefore, the submitted sample did not conform to the specifications and model offered in the bid documents and failed to meet the minimum mandatory technical requirements.

Similarly, the sample submitted by Broad Peak Enterprises was found non-compliant. The bidder had offered an HP 250 G10 Laptop in its bid submission; however, the physical sample presented for technical evaluation was a Dell laptop, which did not correspond to the make and model offered in the bid documents.

In view of the foregoing observations and findings, the Technical Evaluation Committee concludes that the samples submitted by Hans Enterprises and Broad Peak Enterprises do not conform to the specifications and requirements stipulated in the bidding documents and are, therefore, declared technically non-responsive at the sample evaluation stage.

The sample submitted by Aursoft was found to be in complete conformity with the specifications prescribed in the bidding documents as well as the details provided in its bid submission. Accordingly, the sample is declared technically responsive and the bidder successfully qualifies the sample evaluation stage.

### Financial Evaluation

After completion of the mandatory and technical evaluation, the financial proposals were reviewed by the Committee. The following prices were quoted by the bidders:

The Committee noted that although some bidders quoted lower prices, they failed to qualify the mandatory eligibility criteria and were therefore disqualified in accordance with the provisions of the Standard Bidding Documents and KPPRA Rules. However, the Committee further noted that, in accordance with the applicable procurement rules, the contract is to be awarded to the lowest evaluated responsive bidder. As all other participating bidders were declared non-responsive during the mandatory evaluation stage, M/s Aursoft Private Limited remained the only bidder qualifying as responsive and eligible for further consideration.

The Committee further noted that procurement rules require award of contract to the lowest evaluated responsive bidder. Since all other bidders were

declared non-responsive during the mandatory evaluation stage, only M/s Aursoft Private Limited qualified as a responsive bidder for further consideration.

The Technical Members from the ST&IT highlighted that the rates quoted by the responsive bidder seems to be higher than the estimated market rates for similar specification. This observation is placed on record for consideration by the Competent Authority. However, as no other bidder met the prescribed mandatory requirements and qualified as a responsive bidder, M/s Aursoft Private Limited remains the sole responsive bidder in the procurement process.

**Recommendation**

The committee unanimously approved the recommendations of the Technical Members from the ST&IT Department.
