No. SO(HR&MA) 1-70/2017— In exercise of the powers conferred by section 8 of the Khyber Pakhtunkhwa Protection of Communal Properties of Minorities Act, 2014 (Khyber Pakhtunkhwa Act No. XLII of 2014), Government of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:-

## THE KHYBER PAKHTUNKHWA COMMISSION FOR MINORITIES AFFAIRS (TERMS AND CONDITIONS OF NON-OFFICIAL MEMBER) RULES, 2017.

- Short title and commencement:- (1) These rules may be called the Khyber Pakhtunkhwa Commission for Minorities Affairs (Terms and Conditions of Non-Official Member) Rules, 2017.
  - (2) It shall come into force at once.
- 2. Definition:--- (1) In these rules, unless there is anything repugnant in the subject or context:
  - (a) "Act" means the Khyber Pakhtunkhwa Protection of Communal Property of Minorities Act, 2014 (Khyber Pakhtunkhwa Act No. XLII of 2014).
  - (b) "non-official member" means a non-official member of the Commission; and
  - (c) "Search Committee" means the Search Committee constituted for the recommendations of persons to be nominated as non-official member of the Commission.
  - (2) Words and expressions which are not defined in these rules shall have the same meaning as assigned to them in the Act.
- 3. Search Committee:--- (1) The Search Committee shall be consist of the following:

the rank of Additional Secretary

(a) Secretary to Government of the Khyber Pakhtunkhwa, Auqaf, Hajj, religious & Minority Affairs Department Chairman

(b) Representative of the Finance Department not below the rank Of the Additional Secretary; Member

(c) Representative of the Planning and Development Department Not below the rank of Additional Secretary; and Member

(d) Representative of the Establishment Department not below

- (2) The Search Committee shall scrutinize the documents and credentials of the candidates and give its recommendation for nomination as non-official member to Government.
- 4. **Terms and conditions and qualification for the non-official members:-** The non-official member shall be:
  - (i) a person of integrity, good standing and repute having ten (10) years experience with organizations working for the rights of minorities; and
  - (ii) a bonafide resident of Province of Khyber Pakhtunkhwa.
- 5. Disqualification of Non-Official Members:--- The non-official member shall be ;disqualified if:-
  - (i) He remains absent from three consecutive meetings of the Commission; and
  - (ii) His interests come into conflict with the Commission within the meaning of the Khyber Pakhtunkhwa Prevention of Conflict of Interest Act, 2016 (Khyber Pakhtunkhwa Act No. XiII of 2016.
