Terms of Reference (ToRs)

- I. To examine, scrutinize, and approve manuscripts, recordings, digital formats, and other reproductions of the Holy Quran prior to their printing, publication, recording, import, export, or circulation.
- II. To ensure elimination of printing, typographical, transcriptional, recitation, or recording errors in the publication and reproduction of the Holy Quran.
- III. To grant certification for printing, recording, publication, and circulation of the Holy Quran after due verification in accordance with the law.
- IV. To inspect printing presses, publishing houses, recording studios, and storage facilities

- V. To receive, examine, and decide complaints regarding printing or recording errors in published or recorded copies of the Holy Quran.
- VI. To recommend confiscation, recall, correction, or destruction of defective copies containing errors as per legal provisions.
- VII. To advise the Provincial Government on matters relating to accurate, safe, and respectful publication, printing, recording, and distribution of the Holy Quran.
- VIII. To prescribe standards, formats, and procedures for printing, recording, digitization, and publication of the Holy Quran.
- IX. To coordinate with law enforcement agencies, district administration, and relevant authorities for effective implementation of the Act and Rules.
- X. To perform any other function assigned by the Provincial Government under the relevant law and rules from time to time.
